ABOUT THE HAMPSHIRE CO-OP

Our school was founded 47 years ago to provide a cooperative nursery school for the towns of the Upper Valley. We offer morning programs for children 2.9 to 5 years old, a Lunch Bunch Program, and an Afternoon Enrichment Program (non-cooperative) for preschoolers and Kindergarteners. We are fully licensed in the state of New Hampshire and are one of the few preschools in the Upper Valley accredited by the National Academy of Early Childhood Programs.

AFTER SCHOOL ENRICHMENT PROGRAM

The Afternoon Enrichment Program meets from 11:15 -2:30. Kindergarteners may take the bus from the Ray School to HCNS and are met in the parking lot by the teacher or director. Each class includes:

1. Playground time.
2. Lunch (peanut-free and provided by child).
3. Story time when several theme-related books are read.
4. Project time - project related to the stories.
5. Free play - indoors or outside.
6. Clean-up time when all pitch in.

All activities are planned by the classroom teacher to stimulate social, emotional, intellectual and physical growth in your child.

STAFF

Linda Shemanske, our **director** since 1995, received her B.S. in Education from SUNY at Potsdam and is a graduate of Nazareth College with an M.S. in Education. Her experience includes past HCNS parent and president of the HCNS board, 9 years teaching the 3-day class (1986 - 1995), one year teaching the 2-day class at HCNS (2000-2001) and 11 years of teaching Sunday School. Linda is a volunteer and board member for Good Beginnings, an organization that helps families with new babies.

Nancy Menton has been our Afternoon Enrichment Program teacher since 2003. She has a B.S. in Art Education from Plymouth State University and an MBA from Southern New Hampshire University. Nancy's experiences include teaching and substitute teaching in Art from the pre-school to the 12th grade level and 20 years in corporate education. She also spent several years as a helping parent and board member while her children Laurel (12) and Adam (11) attended HCNS. Nancy and her husband, Dan moved to the area five years ago and loves all the outdoor activities the Upper Valley offers.
